**SUMMARY OF VISA REGULATIONS  
IMMIGRATION ACT B.E. 2522 (1979a.d.) AND RELEVANT TEXTS**

1. A valid VISA OF ENTRY is necessary for EVERY ALIEN who wishes to enter the United Kingdom of Thailand, except for certain restricted cases, details of which can be obtained from the Consular Section.
2. All visas are issued according to the stated PURPOSE OF VISIT, which must be CLEARLY STATED by the applicant. Failure to do so shall inevitably incur delays.
3. The visas issued by the Embassy or Consulates only give right to ENTER Thailand and must be used within 3 months from the date of application. Upon arrival in Thailand THE ACTUAL LENGTH OF STAY (starting from date of entry) shall be determined and granted at the discretion of Immigration Officers according to the type and category of visa in possession – Tourist visa not exceeding 60 Days per entry, Transit visa not exceeding 3 Days per entry and Non-Immigration Visa not exceeding 90 Days per entry.

**4. HOW TO APPLY FOR A VISA**

4.1. Complete and sign ONE application form. A separate form is required for each traveller, regardless of age.

4.2. Submit with the completed form -

- Your passport/travel document, which should be valid for a least six months from date of entry.

- TWO recent passport size photographs

- The appropriate fees (see 5) \_\_\_\_\_

4.3. FOR PURPOSES OTHER THAN TOURISM, please submit evidence substantiating your purpose of stay. Examples of such evidence are in case of transit, a confirmed travel document (air ticket etc.) showing Thailand as a point of transit; in case of business trip, a letter from your employers and/or business counterpart in Thailand; in case of work in Thailand, a letter from your prospective employer; in case of settlement in Thailand with Thai Spouse/Children/Parents, your certificate of marriage/birth. For retirement, statement showing proof of financial independence whilst in the Kingdom. Information about satisfying requirements of each category of Non-Immigrant visa is available on request.

4.4. **APPOINTMENTS FOR SAME DAY VISAS WILL BE CHARGED AT £10 ON TOP OF VISA FEE.  
ALTERNATIVELY THESE MAY BE LEFT WITH US AND COLLECTED NEXT DAY**

**5. VISA FEES**

Visa fees can be paid by cash, cheque or postal order, made payable to: ROYAL THAI CONSULATE.

**Tourist Visa**

Effective from 13th November 2015, the Royal Thai Consulate, Liverpool will grant two types of tourist visa to Thailand. Details of the visas are as follows:

Type	Fee	Validity	Length of stay
Single entry tourist visas	£ 25	3 months	60 days per trip
Multiple entry tourist visa (Please see website)	£125	6 months	60 days per trip
• Transit visa £20 per entry (3 days entry/up to 3 entries may be applied for with 3 months validity).			
• Non-Immigration Visa £50 for single entry (90 days per entry with 3 months validity). We are no longer able to issue multiple entry Non-Immigrant visas. Consular Officers reserve the rights to request any additional documents as deemed necessary. Please note all Non-Immigrant applications have to be approved by our Embassy in London and therefore must be submitted at least two weeks before your appointment, either by email to <a href="mailto:suerichardson@boodles.com">suerichardson@boodles.com</a> or handed into reception.			

**6. HEALTH REQUIREMENTS (SUBJECT TO CHANGES)**

Persons holding passports of or having residence in the Yellow Fever Area must produce a valid international health certificate for Yellow Fever at point of entry into Thailand.
